

**The Mary Poppins Look Alike Sweepstakes
OFFICIAL RULES**

NO PURCHASE NECESSARY

PROMOTION DESCRIPTION: The Mary Poppins Look Alike Sweepstakes (the “**Sweepstakes**”) begins on or about July 14, 2010 at 12:01 a.m. Eastern Time (“**ET**”) and ends on July 31, 2010 at 11:59 p.m. ET (the “**Promotion Period**”). Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Blumenthal Performing Arts Center- 345 North College Street, Charlotte NC, 28202 (“**Sponsor**”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal U.S. residents who are eighteen (18) years of age or older and reside in the Charlotte area are eligible to enter. Sponsor, Time Warner Cable Inc., Mary Poppins Road Show and Disney, each of their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (collectively, the “**Promotion Entities**”) and the immediate family members, and/or those living in the same household of each, are ineligible to enter the Sweepstakes or win a prize.

HOW TO ENTER:

To enter online, visit the web site blumenthalcenter.org (the “**Website**”), complete the entry form with the information requested, and click “Submit Entry”. All requested information on the entry form at the Website must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Proof of entering information at the Website is not considered proof of delivery to or receipt by Sponsor of such entry. Except as contemplated in these Official Rules, personal information collected in connection with this Sweepstakes will be used in accordance with the privacy policy found on the Website.

NOTE: Internet entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of any device to automate the entry process is prohibited.

To enter by mail, hand print in ink on a 3" x 5" postcard your full name, complete home address and zip code, home telephone number and area code, date of birth, and e-mail address (if any). Mail this completed card in a first-class stamped envelope to: Mary Poppins Look Alike Sweepstakes C/O Jessica Jarvis at BPAC, 345 North College Street, Charlotte, NC 28202. No metered mail will be accepted. All mail-in entries must be postmarked by July 31, 2010 and received by August 2, 2010. No copies, facsimiles or mechanical reproductions will be accepted. Sponsor assumes no responsibility for lost, late, incomplete, stolen, misdirected, illegible or postage due entries or mail. Limit one (1) entry per outer mailing envelope.

The Website’s database clock will be the official time keeper for online entries in this Sweepstakes. In the event of a dispute regarding the identity of the individual who actually submitted an online entry cannot be resolved to Sponsor’s satisfaction, the affected entry will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any

technical or human error which may occur in the processing of the entries in the Sweepstakes. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. **Limit one (1) entry per person and/or per e-mail address.**

WINNER SELECTION AND NOTIFICATION: At the end of the Promotion Period, the prize winner will be randomly selected from all eligible entries received during the Promotion Period. The potential prize winner will be notified by telephone and/or mail and/or e-mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate prize winner may be selected. **The odds of winning depend on the number of eligible entries received.**

PRIZE/APPROXIMATE RETAIL VALUE: One (1) Grand Prize is available. The Grand Prize consists of 2 opening night tickets to the August 25th performance of Mary Poppins value \$77.50 each (\$155), invitation for winner and guest to attend cast party following performance and \$100 in Mary Poppins merchandise. The approximate retail value (“ARV”) of the Grand Prize is \$255. Sponsor reserves the right to terminate the prize or other applicable experience early, in whole or in part, and send winner and/or his or her companion home with no further compensation.

If winner is unable to participate in the performance during the dates designated by Sponsor, the prize will be forfeited in its entirety. In the event the prize winner is able to participate in the prize during the dates designated by Sponsor but the Mary Poppins performance listed in the prize description does not or cannot take place as scheduled or at all, for reasons including but not limited to scheduling conflicts, cancellations, postponement, or for any other reason, then the Sponsor reserves the right to award the remainder of the prize with no further obligation to the winner. Excepting the preceding sentence, no cash alternative or prize substitutions will be allowed, except Sponsor reserves the right to substitute prize(s) of comparable value if a prize listed or any portion thereof is unavailable for any reason.

GENERAL PRIZE CONDITIONS: Prize winner shall be solely responsible for all federal, state and/or local taxes, and the reporting consequences thereof, and for any other fees or costs associated with the applicable prize. Any potential prize winner may be required to execute an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, “**Prize Claim Documents**”). The Grand Prize winner’s guest may also be asked to execute applicable Prize Claim Documents prior to ticketing of the Grand Prize. If winner fails or refuses to sign and return all Prize Claim Documents within five (5) days of prize notification (or a shorter time if required by exigencies), winner may be disqualified and an alternate winner may be selected.
